Eligibility:

Open to all amateur athletes who have a current **INBF card (\$50 USD)** (**IMPORTANT: Dues must be sent to the INBF in the U.S.A and must be a certified cheque payable in US funds to INBF INC. NO PERSONAL CHEQUES accepted**) (Dues include subscription to NB&F magazine) or may obtain one no later than 15 days before the date of the show. Athletes must be drug free seven (7) years from the date of the show.

To be eligible to compete in the INBF Canadian Natural Bodybuilding and Figure Classic, competitors must complete and submit this entry form along with all required competition fees.

Overall winners for the open classes in bodybuilding and figure will qualify for WNBF pro status. Masters winners will be qualified to compete in all WNBF Pro Masters events.
