Polygraph Testing:

Competitor will be responsible for booking own test with polygrapher in that 2 week period. Must do polygraph or will be unable to compete in competition. Banned Substances List

The following substances and related compounds are banned by The WNBF and INBF, and their use constitutes grounds for dismissal from WNBF and/or INBF competitions and suspension from membership privileges in the organization for a period of seven (7) years from the failure date. The list is effective as of January 1st, 2012.

The athlete is solely responsible for what goes into his or her body. If you are not sure of the status of a supplement or pharmaceutical, contact Charlie Carollo by phone (570) 643-0139 or email inbf@epix.Net.

Note: athlete's status will be viewed on a case-by-case basis.

ANABOLIC STEROIDS – All Anabolic Steroids, including but not limited to bolasterone, boldenone, chioroxomesterone (dyhdrochlormethyltesterone), clostebol, fluoxymesterone, mesterolone, methandienone, methyltestosterone, nandrolone, norethandrolone, oxandrolone, oxymetholone, stanozolol, testosterone and all other related compounds are strictly banned.

TESTOSTERONE – (injections/patches/gels) In any form or for any reason, even if under a doctor's prescription are strictly banned.

TESTOSTERONE/EPITESTOSTERONE (T/E) RATIO – The T/E ratio is used to measure the presence of exogenous testosterone or illicit elevation of testosterone levels. A T/E ratio in excess of 6/1 is ruled as positive, no matter what the cause. Note: Should the use of any substance cause a T/E ratio in excess of the 6/1 limit, the athlete will be ruled as positive (failure).

GROWTH HORMONES – (PHARMACEUTICAL HGH, HCG and any other related compounds). Oral, spray or sublingual GH compounds of pharmaceutical (recombinant DNA technology) origin are banned.

HORMONES, PROHOMONES AND ALL PRECURSORS AND METABOLITES, DERIVATIVES & RELATED COMPOUNDS – The use of any hormone (injectable, oral, sublingual or otherwise) for bodybuilding purposes – including insulin – is prohibited. All hormonal precursors (DHEA, androstenedione; 19norandrostenedione; andrestenediol; 5AD; androstene TRIONE; 17androdione; etc.) are banned. All other additional hormonal supplements (60XO; 60XOandrostenetrione; 2a, 17adimethyl17ß-hydroxy5aandrostan3one; 3, 17ketoetiocholtriene; 1,4,6androstatriene3, 17dione; 3Alpha (5aandrostane-3a, 17bdiol); etc.) have been identified as prohormonal in nature and are banned. FatBurning Prohormone Derivatives such as 3, 17dihydroxydelta5etiocholane7one (A7D), 3, 17-dihydroxydelta5etiocholane7one diethylcarbonate (A7E), etc. are banned. 7-oxo-DHEA (also known as 7-keto-DHEA), 7alpha-hydroxy-DHEA (7alpha-OH-DHEA) and 7beta-hydroxy-DHEA (7beta-OH-DHEA) are not banned by the WNBF or INBF when used for weight loss. Although hormonal metabolites of DHEA, they do not elevate testosterone levels and can be used by WNBF or INBF athletes. ProSteroids are banned. They are marketed as not being prohormonal, but they are. Prescription Thyroid Hormone Medication, when used for bodybuilding purposes, is banned. The presences of any banned substance in the urine (i.e., nandrolone, etc.), no matter how arrived is ruled as a positive (failure).

INBF COMPETITOR'S ONLY – Any athletes who are new to the INBF must have not used any prohormones for at least two (2) years before joining the INBF for the first time. NOTE: be sure to check all ingredient lists for supplements before using them.

PRESCRIPTION DIURETICS – Any and all prescription weight loss substances and diuretics used for bodybuilding purposes, even when physician prescribed cannot be used for six (6) months prior to WNBF and/or INBF competitions.

DMAA, 1,3-DIMETHYLAMYLAMINE AND GERANIUM and all related compounds are banned effective August 31, 2012.

EPHEDRINE, EPHEDRA AND ALL RELATED COMPOUNDS are banned. Any athletes who are with the INBF ONLY must have not used ephedra for at least six (6) months before joining the INBF for the first time.

PSYCHOMOTOR STIMULANTS such as amphetamines, speed, cocaine or other stimulants when used for bodybuilding purposes are banned.

MUSCLE IMPLANTS OF ANY KIND are strictly prohibited.

CHEMICALS/DRUGS FOR THE PURPOSE OF DECEIVING OR PASSING THE POLYGRAPH OR URINE TEST are banned.

CLENBUTEROL AND GHB are banned.

ANY ILLICIT/ILLEGAL BODYBUILDING DRUG/ SUBSTANCE AS DECREED BY U.S. GOVERNMENT AGENCIES.

ANY FDA BANNED SUBSTANCE, EXCEPT IF Specifically OTHERWISE INDICATED.

All INBF and WNBF athletes must be seven years drug free of prescription /pharmaceutical hormones on the banned substance list and two years free of over-the-counter hormones, pro-hormones or banned substances listed or their chemical counterparts, unless otherwise noted, prior to their first WNBF-qualifying competition. I have read the above additional banned substance list and I'm not in violation of it.

NOTE: All existing INBF members are still eligible to compete up until the expiry of their INBF membership (Application sent to USA). Once expired the athlete is then expected to fill out an INBF Canada membership form. Each bodybuilding competitor is responsible for supplying his/her own routine music. Please bring 2 copies (CD only) to be handed in at the mandatory competitor's meeting. Each CD must contain ONLY the 90 second routine music. NO PROFANITY PLEASE.

In consideration for your acceptance of my application to join the amateur International Natural Bodybuilding & Fitness (INBF) Canada Federation, Inc., pending my earning membership via winning a certified pro-qualifying amateur contest, I understand and agree to abide by all the rules and by-laws, as amended, of the INBF Canada, including the drug-free and conduct policies of the organization. I understand that, in order to compete in an INBF Canada-sanctioned event, I will be required to submit to up to two (2) drug-tests to validate a seven-year absence from the use of any type of steroids, hormones, prohormones, prescription diuretics and any an all other compounds or performance-enhancing substances or actions deemed illegal by the INBF Canada. I will also be asked to validate an absence of muscle implants via drug-testing. Such testing will be done through polygraph (lie-detector) and urinalysis exams. I further agree to abide by the decision of the INBF Canada concerning my participation in an INBF Canada-sanctioned event contest pending the results of both tests, as well as my adherence to any and all of the INBF Canada rules and regulations. Failure to pass INBF Canada drug-tests or failure to adhere to all INBF Canada rules and regulations will result in my expulsion from the competition in question, as well as the loss of my INBF eligibility for seven years. I also agree to submit to any and all out-of-season drug-testing required by the INBF Canada, and agree to stand by the results of said testing, whatever it may be.

WAIVER: In consideration of your accepting this entry, I hereby intend to be legally bound for myself, my heirs, executors and administrators, and waive and release any and all rights and claims for damages I may have against the INBF Canada, Inc. (INBF), Eva O'Howard Theatre (Victoria School of Performing Arts), World Natural Bodybuilding Federation, Inc. (WNBF), Mathew Park, Rozanne Pyper, Lael Sauter, Cheryl Glattacker and any sponsors, agents, representatives and assigns for any injuries and/or losses suffered by me as a result of my participation and/or attendance at the 2012 INBF Canada Alberta Cup, Saturday November 3rd, 2012, or for any and all media coverage thereof. I understand that, in order to compete in an INBF Canada-sanctioned event, I will be required to submit up to two (2) drug tests to validate a seven year abstinence from the use of any type of steroids, hormones, pro-hormones, prescription diuretics and any and all other compounds deemed illegal by the decision of the INBF Canada concerning my participation in an INBF Canada-sanctioned contest, pending the results of one or both tests, as well as my adherence to all INBF Canada rules and regulations. Failure to pass INBF Canada drug tests or failure to adhere to INBF Canada rules and regulations will result in my expulsion from the competition in question, as well as loss of INBF Canada eligibility for seven years. I also agree to submit any and all out-of-season testing required by INBF Canada and agree to stand by the results of said testing, whatever it may be.
